4. have sent to the municipality, at the address indicated below, an application for entry on the list of electors not later than :

AND

→ to the undivided co-owners of an immovable and the co-occupants of a business establishment who are not already entitled to be entered on the list of electors as a domiciled person, sole owner of an immovable or sole occupant of a business establishment that they can be entered on the list of electors for the current election if they meet the following conditions:

1. be 18 years of age on:

2015 11 29 \*  
year month day

2. be a natural person, a Canadian citizen, not be under curatorship on:

2015 08 20 \*\*  
year month day

and, on that date, not have been convicted, over the last five years, of an offence that is a corrupt electoral practice

3. be the undivided co-owner of an immovable or co-occupant of a business establishment situated in the territory of the municipality for at least 12 months on:

2015 08 20 \*\*  
year month day

4. have designated by means of a power of attorney signed by the majority of the co-owners or co-occupants who are electors on:

5. have sent to the municipality, at the address indicated below, a power of attorney not later than:
